- <u>Aaron Makovka</u>, Lawyer, Dunton Rainville (Canada: Quebec). Aaron is a long-time network member and, in June of this year, his firm hosted the annual SCG Legal Team Canada Regional Meeting. All nine Canadian member firms—represented by 45 participants in total—convened for an agenda focused on improving operational efficiencies, business development opportunities, advancements in legal technology, and the importance and benefits of gender equality in the workplace. Special guests included The Honourable Irwin Cotler, a former Canadian politician known for his human rights advocacy, and Mario Lefebvre, a key figure in the music world in Quebec, who played a pivotal role in the success of renowned artists like Pink Floyd and Celine Dion.
- Clíodhna Walsh, Partner, Beauchamps (Ireland). Beauchamps was the local host/member firm for SCG Legal's 2024 Midyear Meeting in Dublin, which has now been recorded as the organization's largest Midyear Meeting to date, including 30% of the attorneys in attendance experiencing their very first in-person network event. A highlight of the agenda was the keynote featuring Bertie Ahern, former Irish Prime Minister, and Liz O'Donnell, former Government Minister of State.
- Paul Plunkett, Shareholder, Larkin Hoffman (US: Minnesota). Paul is a long-time network member and Immediate Past Board Chair. Under his leadership, the network hosted its largest in-person Midyear Meeting to date; established a Board of Directors Emeritus Council to support and mentor new member firms as well as next generation network leaders; launched a proprietary artificial intelligence (AI) initiative to assist member firms in determining how AI can be strategically deployed to create operational efficiencies; launched a proprietary Diversity, Equity, and Inclusion (DEI) Advocate™ Certification Program to recognize and support member firms actively working to cultivate an internal culture of inclusion and belonging while driving change in the legal industry at large; and grew the proprietary New Partner Institute, a virtual leadership program designed to springboard the careers of newly promoted member firm partners, to 148 alumni around the world.
