### DOWNLOAD THE APP

1. Open the App Store (iPhone) or Google Play Store (Android) on your phone. [See above for a QR code.]
2. Search for **SCG Legal**. [See app icon above.]
3. Choose **Download** or **Install** (depending on your service provider).
4. Once downloaded, choose **Open**.

### LOGGING IN FOR THE FIRST TIME

1. Once you open the app, you will be presented with a Permissions Info screen. Choose **Continue**. If asked to allow for Notifications, choose **Allow**. (You can change this setting later.)
2. In the upper right corner, choose **Sign In**.
3. Choose **Login with Firm/Company Email**.
4. Click on the box to accept **Terms of Service** and **Privacy Policy**.
5. Click on **Sign In**.
6. An authentication screen—asking for a code—will appear. (Do NOT close this screen.) Check your email (the one you used for the **Sign In**) for the code. (See below for example email. Please check your SPAM/Junk folder if the verification email does not show up in your Inbox.) Enter the received code on the authentication screen.

**NOTE:** There may be a delay—several minutes or longer—in receiving this email depending on server traffic. During this time, the login screen may appear to buffer.

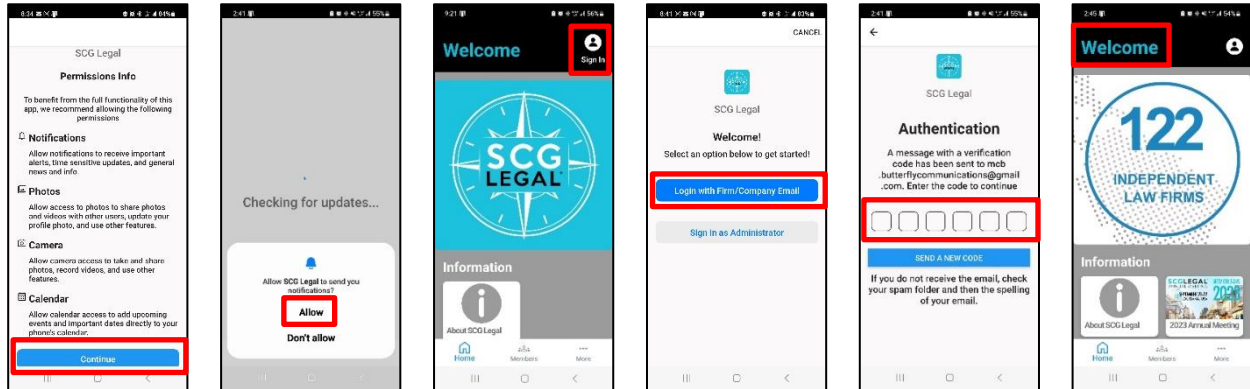
